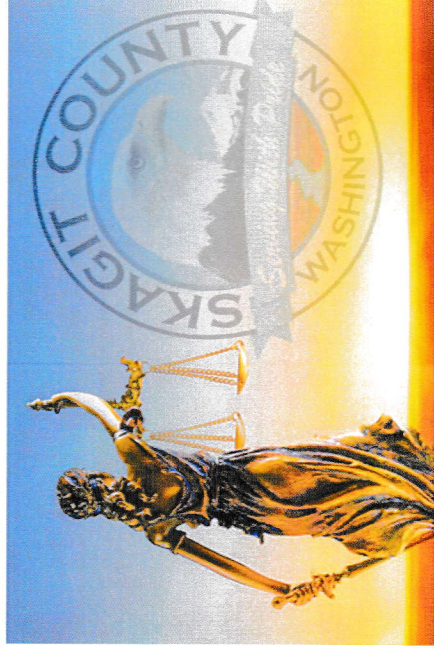
Intrigued the samurai urged his horse towards the cat. Just then, a bolt of lightning flashed and struck the tree behind him, splitting it in two.
